


"What's this?" Carl asked. "It's your stuff," the man explained. "It's your stuff back. Even the money in your wallet."


"I don't understand," Čarl said. "Why would you help me now?"

Carl looked down at the sack in his hands and gingerly opened it.... *to be continued in April* 







## Mint Chocolate Chip Fudge

- 2 1/2 C White Choc Chips
- 1 (14 oz) can sweetened Condensed Milk
- 2 tsp Peppermint Extract
  - 6 8 drops green food coloring



Line an 8x8 pan with parchment paper or foil lightly greased with cooking spray. In a large heatproof bowl over a pan of simmering water (do not let the bowl touch the water), melt together the white chocolate chips and sweetened condensed milk, about 5 minutes (do not rush this process). Remove the bowl from pan. Stir in the peppermint extract and food coloring. Wait 2 minutes then fold in 1 cup chocolate chips (the more you fold, the more they'll melt). Spread into the pan and top with the remaining 1 cup chocolate chips, gently pressing down to stick into the fudge. Cool until firm, at least 4 hours or overnight (you can store in the refrigerator to speed up the process). Store in an airtight container for up to 1 week.

#### DENT UNITED METHODIST CHURCH COUNCIL February 16, 2022

The regular meeting of the DUMC Council was held on Wednesday at 3:00 at the church. Members present were KellyAnn Augustson, Doris Champlin, Don Garber, Austin Holtz, Peggy Meissner, and Ivy Mickelson. Doris called the meeting to order.

**MINUTES:** Minutes from last meeting were in the newsletter. Austin made a motion to accept the minutes with a second from Ivy, motion passed.

**FINANCE:** Report shows our last month expenses were more than what we brought in by \$2000. Don reported that we received a Memorial of \$150 from the Miller family. Ivy has been looking for someone to audit the books with no luck. A motion was made by Peggy to have the monthly insurance payment made automatically with a second from Kelly Ann, motion passed.

**COMMITTEE REPORTS:** Trustees had nothing to report. We had a discussion about who is plowing our parking lot. Nobody knows at this point who it may be. We have not received a bill for the job. Thank you to whoever is doing the job.

**MISSIONS:** The mission offering for the months of February and March will be The Bridge Food shelf.

**WORSHIP:** We discussed if we should still require people to wear masks, Don made a motion to make masks an option from now on unless things change. Austin made a second and motion passed. We decided to wait to do fellowship after church for now. The council had a discussion of the handling of the offering. We would prefer if the plates were on the table in the entry.

**MEMORIAL & TRUST FUNDS:** Doris has sent a request for funds from the Foundation fund for the mission giving.

**OTHER:** we decided to put a notice in the newsletter for the piano for sale. Rose Thompson has been doing a wonderful job sending cards to people for birthdays and other events. Peggy made a motion to give her \$100 for the cards she buys. Kelly Ann seconded, and motion was passed. Doris received information from Central Market on the cost of catering funerals. It was decided to table the discussion on our funeral policies until next meeting so we can gather more information.

**NEXT MEETING & ADJOURNMENT:** Next scheduled meeting will be March 16. Meeting adjourned.

#### VERGAS AD COUNCIL MINUTES Zoom Meeting Feb 16, 2022, 3<sup>rd</sup> Wednesday

Those present: Renee Sonnenberg, Sheri Schoenberger, Jane Wasvick, Carmen Moore, Tanya Johnson, and Faye Courneya

Call to order by our Chairwoman Renee.

Pastor Amy was not able to attend due to an illness. Sheri reported that attendance is steady in the last month in Vergas, generally in the low 20's with online attendance in the high 20's.

<u>Secretary minutes</u> approved after a motion to approve from Jane, a second by Sheri, and carried.

**Treasurer's Report:** Jane moved that the treasurer's report be approved as sent out, was seconded by Tonya, and carried.

### **Old Business:**

We were not aware of a local need for the mission allotment this month. The little library has cost \$401 so far with more expense anticipated by the time is it mounted by Myles. So the local missions money of \$300 will be left to finish the little library and maybe buy a few good children's books to supply it.

#### New Business:

- 1. Faye told us the \$35 <u>membership dues for community club</u> will need to be paid. Jane moved that the dues be paid for Community Club membership and that they continue to be paid yearly. It was seconded by Tonya and carried.
- 2. Dent church treasurer has asked us to audit the Dent church books, but there is no one in our church to do this. We may need to hire some one who is capable of doing this; Faye and Sheri will ask some other organizations and churches how they get their audits done, so we may be able to propose a plan on how to get this done at our next meeting.
- 3. **Color Copies:** This expense has been excessive over the last year and we have not got that much allowance in our budget for them. The contract with Marco allows for 15,000 B&W copies and only 750 color copies. In January, 4290 color copies were made and we were billed \$374 for them. June to December 2021, 8,206 color copies and 3402 B&W copies were made, thus we were billed \$788.84 for them (even a tiny dot of color in a copy will cause it to be billed as a color copy). Fewer color copies can be used and B&W copies would be sufficient. Tonya moved that we have B&W copies for weekly bulletins, except for holidays when color copies could be used for service bulletins. This was seconded by Jane and carried.
- 4. Sheri will write a service order for the scanner to be fixed.

#### **Other Business:**

**Stair Lift**: Connie Prunty is going to pay 100% of the cost of the chair lift that she is arranging to be installed at the church. The council felt that another person (perhaps a trustee) to represent the church building be present, in case the installers have questions or need some building alterations in order to make the installation.

<u>**Covid restrictions**</u>: Any changes that may be in order in lieu of the relaxing of some covid restrictions and increased vaccinations, were tabled until next meeting in the event that the Bishop's suggestions will be changed.

# Next Month's AD Council Meeting will be a Zoom meeting on March 16<sup>th</sup>.
